The USDA has issued nationwide waivers which allow school districts and community organizations to extend the operation of the Summer Food Service Program into the current school year through August 6th or until available funding runs out.

Alta-Aurelia Community School is participating in the USDA Summer Food Service Program during this time, which will allow for a safe and streamlined service of nutritious meals. Meals will be provided to ages 1-18 without charge. FREE meals will be provided at the sites and times as follows:
